

**REGULATION**

**NON-RESIDENTS' TUITION FEES**

**FUTURE RESIDENTS**

The Board of Education grants the request of parents/guardians to enroll their children in the schools of Holmdel Township if they have signed a contract to buy, build, or rent a residence in this district. The parents/guardians who are future residents shall be required to demonstrate proof of the anticipated residency and to provide payment of tuition for each child in accordance with this fee schedule at the time of registration:

- The tuition rate for the first semester of attendance:

K-5	\$2,100
6-8	\$2,700
9-12	\$3,200

- The tuition rate for the second semester of attendance:

K-5	\$4,200
6-8	\$5,400
9-12	\$6,400

- The tuition rate for Special Education programs for the year are:

Resource Center Program	\$4,200/\$4,200
PSH, LD, & CH Classes	\$5,000/\$5,000

- Tuition charges for further enrollment of non-resident students beyond two semesters is subject to review and approval by the Board of Education on a case-by-case basis.
- Tuition must be paid in advance of each semester and will be returned on a prorata basis as soon as proper certification of closing is presented to the Board of Education Business Office.
- The check for the payment of the semester's tuition for each student wishing to enroll must accompany the anticipated residency documentation before approval to register can be granted.
- The Board reserves the right to verify such claims and to remove from school a non-resident pupil whose claim cannot be verified.

## **NON-RESIDENTS' TUITION FEES**

- The Board shall not be responsible for the transportation to or from school of any non-resident pupil
- The Board shall annually determine tuition rates for non-resident pupils.
- The tuition rates for future residents are effective immediately.

## **FORMER RESIDENTS**

Regularly enrolled children, whose parents/guardians move out of Holmdel Township during a school year, shall be permitted to finish the current school year in accordance with this tuition schedule on a prorata basis.

- The tuition rate for continued attendance is:

K-5	\$6,300 prorated/per diem possible days
6-8	\$8,100 prorated/per diem possible days
9-12	\$9,600 prorated/per diem possible days
- For currently enrolled seniors at Holmdel High School to complete the 1994-95 school year, effective January 1, 1995, the tuition rate will be fixed at 40% of the annual rate prorated/per diem possible days as stated above for continued attendance for grades 9-12.
- For enrolled seniors, effective with the 1995-96 school year, the tuition rate will be fixed at 80% of the annual rate prorated/per diem possible days as stated above for continued attendance for grades 9-12.
- Enrollment will not be permitted beyond the school year in which approval is granted.
- Tuition must be paid immediately upon the approval for continued enrollment as described above.
- The Board reserves the right to remove from school a non-resident pupil whose parents/guardians have not paid the tuition fee.
- The Board shall not be responsible for the transportation to or from school of any non-resident pupils.
- The Board shall annually determine tuition rates for non-resident pupils.
- The tuition payment for students K-11 is effective immediately in accordance with past practice.
